NPPTF Letter About Long-Term Care Regulation

The National POLST Paradigm Task Force (NPPTF) submitted a letter to the Centers for Medicare and Medicaid Services regarding the proposed regulation **CMS-3260-P, Reform of Requirements for Long-Term Care Facilities**. The letter requests that POLST be included in the requirements that Long-Term Care facilities must meet to participate in the Medicare and Medicaid programs.

The deadline for comments has been extended to October 14th. We strongly encourage individuals and state POLST programs to submit comments encouraging the inclusion of POLST in these revised regulations.

New End-of-Life Care Reports

A number of organizations have recently released reports detailing the state of advance care planning in the United States. Among them, the Kaiser Family Foundation **conducted a poll** that found a vast majority of the public believes that physicians should have end-of-life conversations with patients and that they should be reimbursed for it. The results of the survey were further shared in the national media, including this [Huffington Post article](#).

In addition, the **Center to Advance Palliative Care** has released a **state-by-state report card** on access to palliative care. The report card provides each state with a numerical

Distinguishing POLST from Death With Dignity Statutes

In September the National POLST Paradigm Task Force (NPPTF) released a statement articulating the differences between the National POLST Paradigm and Death with Dignity (DWD) statutes. There are 10 states currently considering DWD legislation during this legislative session and 12 states that considered, but did not pass, such legislation. Most notably, on October 5th California Governor Jerry Brown signed a DWD statute into law.

The NPPTF drafted this statement to prevent confusion between the National POLST Paradigm and DWD statutes; this statement underscores the differing origins, motivations, and outcomes associated with POLST and DWD. With DWD legislation regularly being considered and debated, the NPPTF hopes this statement will prove helpful for any POLST Program seeking to communicate these differences to the media and the public.

Advance Care Planning Among Patients with Cancer

A recent article in [JAMA Oncology](#) explores trends in advance care planning among patients with cancer between 2000 and 2012. The authors obtained survey responses from next-of-kin for 1985 patients who died of cancer to determine rates of durable power-of-attorney and living will creation, as well as advance care planning discussions.

The study demonstrated that rates of durable power-of-attorney creation have significantly increased from 2000 to 2012 (52% to 74%). However, there was no significant change in creation of living wills or advance care planning discussions. Despite the increase in durable power-of-attorney creation, there was an increase in patients receiving all care possible and no change in rates of hospitalizations.

The results indicate that there is more work that must be done to promote advance care planning discussions and the preparation of advance directives. Furthermore, the results suggest that increasing creation of durable power-of-attorney does not relate to limiting or withholding treatment. As a result, this document may not be adequate for patients who wish to forgo life-sustaining treatments when facing serious illness.
