Featured Research: Which specialists sign POLST Forms?

The American Journal of Hospice & Palliative Medicine recently published an article by Austin Lammers, Dana Zive, Susan Tolle, and Erik Fromme, "The Oncology Specialist's Role in POLST Form Completion." Based on data from deceased cancer patient statistics determined from the Oregon POLST Registry, the study authors found that 41% of patients had a POLST Form in the Registry, and that most (53.7%) were signed by primary care, vs. 14.9% by oncologists.
