Research study: POLST most effective and helpful tool in nursing home care.

A research paper, "Stakeholder Perspectives on the Optimizing Patient Transfers, Impacting Medical Quality, and Improving Symptoms: Transforming Institutional Care (OPTIMISTIC) Project" was published in *The Gerontologist*, authored by Mary Ersek, PhD, RN, Susan E. Hickman, PhD, Anne C. Thomas, PhD, ANP-BC, GNP, FAANP, Brittany Bernard, BS, and Kathleen T. Unroe, MD, MHA. The study was aimed at improving care for nursing home patients via the implementation of a multicomponent collaborative care model, which included advance care planning and specifically the use of POLST (in this study called POST, or Physician Orders for Scope of Treatment, since the study took place in Indiana). A key result was that POST was the tool most frequently cited as effective by the stakeholders, a view upheld by RNs, providers, families, and facility staff. Colorado MOST study reveals high quality POLST use in heart failure patients.

"Use of Medical Orders for Scope of Treatment for Heart Failure Patients During Postacute Care in Skilled Nursing Facilities," by Hillary Lum, MD, PhD, Oluyomi Obafemi MD, Joanna Dukes MS, Molly Nowels MA, Kristina Samon BSN, and Rebecca S. Boxer MD, MS, was published to *JAMDA (Journal of the American Medical Directors Association - The Society for Post-Acute and Long-Term Care Medicine)*. Similar to recent POLST research in [West Virginia](#) and [Oregon](#), this study in Colorado found that POLST (there called MOST, or Medical Orders for Scope of Treatment) is used appropriately and effectively, in this case within a study population of heart failure patients admitted to Colorado skilled nursing facilities (SNFs). Conclusion: 75% percent of patients with heart failure admitted to SNFs had care preferences documented using the MOST form, and 95% received goal-concordant care based on care preferences documented during the SNF admission. Physician Assistants can now sign West Virginia POLST Forms. West Virginia's POLST Paradigm Program, called POST (Physician Orders for Scope of Treatment) now includes physician assistants as POST Form signers, effective September 9, 2017. With this measure, signatory authority is now granted to all doctors (MDs), osteopathic physicians (DOs), Advanced Nurse Practitioners (APRNs), and Physician Assistants (PAs) in West Virginia. The [WV Center for End-of-Life Care](#) has updated their POST Forms to reflect this change in [legislation](#).
