Emergency simulations demonstrate frequent misinterpretations of POLST

Mirarchi et al tested clinicians' ability to correctly integrate POLST and Living Will information during live emergency room simulations where a patient loses their pulse and stops breathing. The decision to attempt CPR (or not) was considered appropriate if consistent with the patient's documentation. Whether the clinician made the appropriate decision depended on what kind of documentation (POLST, Living Will, neither) the patient had and what the POLST orders were. Clinicians struggled the most with POLST

DNR/CMO orders, providing resuscitation 73% of the time in a DNR/CMO scenario for a patient with an incurable cancer. <u>View article</u> (PubMed, limited access).
